### In 2020, Jamboree marks 30 years of building for good!

Our yearlong celebration kicks off with the grand opening of Veterans Village in Santa Ana. This 75-unit development is Jamboree's first dedicated property for veterans struggling with homelessness and a range of other challenges – adding to the **800+ veterans** who already live in Jamboree properties across California. It's designed to be a *hub of hope and a sanctuary of stability* – and **Orange County's largest housing development exclusively for veterans**.

As one of the nation's largest nonprofit affordable housing developers, Jamboree developments are **platforms for community change**, with more properties, partners, and programs – and with **proof of the impact** our solutions are making to truly change lives – including those of local veterans.

With a goal to **end veteran homelessness** in Orange County, Jamboree is committed to a shared strategy with community partners that has proven to create long-term stability and success for our residents.

As Orange County's largest provider of permanent housing with supportive services, we bring together partners from broadening sectors. The result? **More than 475 residents** with mental illness who've previously lived on the streets now have a stable home with the quality services they need to thrive.

At Veterans Village, a comprehensive mix of onsite services will be provided by a **growing network of veteran organizations** that include the Veterans Administration Long Beach Health Care System, Good Will of Orange County's Tierney Center for Veterans Services, the Veterans Legal Institute, the OC Health Care Agency, and many more.

Thanks to our funding partners and the expertise of our design and construction partners and staff, what we've built continues to create **a ripple effect** that promotes healthy living, generates jobs, produces supportive housing – and builds stronger communities.

Our **vision for 2020** (and beyond) remains clear: *Every person will live in a strong, healthy, sustainable community.* And, our mission drives us to do more.

In the next 18 months, our **\$627 million development pipeline** includes hundreds more affordable and supportive housing units:

Collaborating with the City of Anaheim, a new motel conversion ordinance will more quickly convert existing motels into housing for those formerly homeless. The first such property is Jamboree's transformation of a former Econo Lodge into 70 units of affordable housing. **Twenty studios are for veterans**, who will access veteran services onsite. In Santa Ana, we're converting a Budget Inn into housing for another **90 formerly homeless veterans**, who will access veteran services at nearby Veterans Village.



Behind our numbers are countless inspiring stories of hope, change and opportunity made possible through the combination of affordable housing with services. This is **building for good**.
